

Restraints: Changed Device/Points for Nurses

Cerner FirstNet and PowerChart EDUCATION

After restraint initiation, if an alternative type of restraint device or change in restraint points that would be more appropriate for the patient then what was ordered, the following needs to occur:

- The original restraint order needs to be discontinued via the Restraint Monitoring form.
- A new order must be placed.

Follow the steps outlined below for a provider or nurse entered change of device/points restraint order.

Provider Entered Changed Device/Points Restraint Order

Note: A new Restraint Initiation task will generate with the new restraint order. Do not document on the New Restraint Initiation task until the steps below are completed.

The provider enters a new restraint order for different device/points.

- 1. Open the **Restraint Monitoring** Violent or Non-Violent form via Ad Hoc or the CareCompass/LaunchPoint task.
 - a) The form will auto-populate with information from the Restraint Initiation with Date and Time.
 - b) In the mandatory field, Restraints Still Needed, select **Changed device/points**.

The Restraint Discontinuation form opens. a) In the Discontinue Restraint Order field, select Yes . b) In the Discontinue Criteria Met field. - 1. Open the Restraint Monitoring Non-Violent or Violent form via Ad Hoc or the CareCompass/LaunchPoint task.
 - a) The form will auto-populate with information from the Restraint Initiation with Date and Time.
 - b) In the mandatory field Restraints Still Needed, select Changed device/points.
