

Opioid Risk Screening for Providers, Clinical Staff and Care Managers

Summary: Opioid Risk Screening should be completed for patients upon an initial visit prior to beginning or continuing opioid therapy for pain management. The Opioid Risk Tool is found on the Medicare Annual Wellness Visit form, Scales and Assessments on the Ambulatory Workflow pages, and via AdHoc.

Opioid Risk Screening Documentation

- Opioid Risk Screening should be completed for patients upon an initial visit prior to beginning or continuing opioid therapy for pain management.
- Documentation may be completed from the Medicare Annual Wellness Visit form, Scales and Assessments, or via AdHoc.

Documenting Opioid Risk from Medicare Annual Wellness Visit:

- Select Medicare Annual Wellness Visit from the Vital Signs component drop down on the Workflow page.
- Select Opioid Risk Tool within the PowerForm.
- Complete the Opioid Risk Tool.
 - The Score and Interpretation will auto populate based on answers.
- Notify the provider of a score equal to or greater than 3.

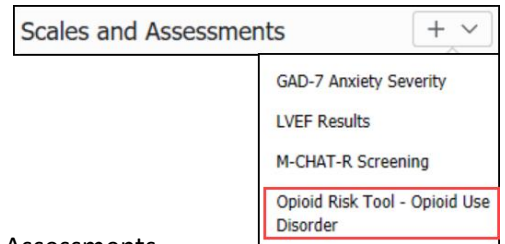

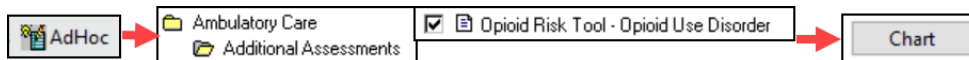
Documenting Opioid Risk from Scales and Assessments:

1. Select Opioid Risk Tool from the Scales and Assessments component on the Ambulatory Workflow page.
2. Complete the Opioid Risk Tool.
3. Notify the provider of a score equal to or greater than 3.



Documenting Opioid Risk from AdHoc:

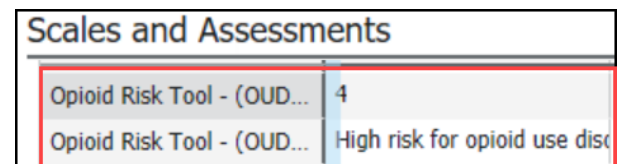
1. Click AdHoc on the top toolbar, open Ambulatory Care and Additional Assessments folder, select Opioid Risk Tool-Opioid Use Disorder and click Chart.



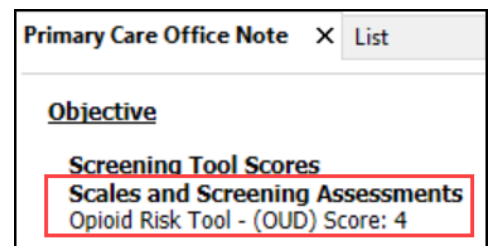
2. Complete the Opioid Risk Tool.
3. Notify the provider of a score equal to or greater than 3.

Providers

- Clinical Staff will notify providers of an Opioid Risk score equal to or greater than 3.
 - A score of 2 or lower indicates low risk for future opioid use disorder; a score of greater than or equal to 3 indicates high risk for opioid use disorder.
- The Opioid Risk Tool Score and Interpretation will display on the Scales and Assessments component of the Ambulatory Workflow pages.



- The Opioid Risk Score completed on the day of the visit will flow into select notes under Objective, Screening Tool Scores.
- List of Notes Affected:
 - Assisted Living Note
 - Diabetes Management Clinic Note
 - Home Visit Note
 - Long Term Care Note
 - Medicare Wellness Exam
 - Preventative Health Exam
 - Primary Care Note
 - Weight Management Office
 - Well Child Office Note



- If the patient screens as high risk for future substance abuse risk, provide appropriate follow up.
