# 21st Century Cures Act

**Summary of Information Blocking** 

**Summary:** The 21st Century Cures Act (Cures Act) is intended to facilitate requests for electronic medical records returned in an electronic format. In part, the Cures Act prohibits information blocking. This means that Munson Healthcare cannot knowingly interfere with access, exchange, or use of electronic health information by those with a valid, legal right to request information including, but not limited to, patient, payer, provider, or insurance.

The Cures Act requires that if we are unable to supply the requested electronic health information in the specific electronic format requested, the requester must be notified in writing within 10 days of their request.

When: April 5, 2021


**Why the change:** To improve continuity of patient care, promote patient safety and empower patients to be involved in their care by having access to their electronic health information in an electronic format.

## What Electronic Health Information is Included

The Cures Act requires the following data elements be made available in an electronic format upon request unless the requirements of an exception available under the Cures Act regulations are met.

## Handling a Request for Electronic Health Information in a Specific Electronic Format

### Process for electronic health information requests

If asked or approached regarding a request for electronic health information to be provided in a specific electronic format, do the following:

- If the requester has not already submitted a valid request have the patient complete **Request Form #0525**, Authorization for Release of information: Form Found Here.

- Effective immediately, all MHC entities and providers, including hospitals, ambulatory offices, home care, hospice, PT/OT/speech, and long-term care, should use Munson Healthcare Form #0525 'Authorization for Release of Health Information'. This form has been revised to identify requests for electronic health information which would be subject to Munson Healthcare's Health Information Management and Information Technology workflows put in place to comply with the information blocking portions of the Cures Act.

- Munson Healthcare cannot deny or refuse a request if the valid request is submitted using a different form.
