# DEA X-WAIVER TRAINING NO LONGER REQUIRED TO PRESCRIBE BUPRENORPHINE

(for opioid use disorder)

# FOR PHYSICIANS AND APPs, TRAINING IS NO LONGER REQUIRED

This allows ED and inpatient providers to supply a DISCHARGE prescription for buprenorphine (BUP) to appropriate patients. Prescribing BUP while a patient is in the ED or hospital is still unlimited.



Already X-waivered? No need to take any action.



## HOWEVER, A "NOTICE OF INTENT" FORM TO SAMHSA IS REQUIRED

This process is simple and quick. See page below for step-by-step instructions on how to complete a notice of intent (NOI). This takes 4 to 6 weeks for turnaround.

# WHAT IS THE "30 PATIENT RULE?"

An inpatient or ED provider can have 30 ACTIVE BUP prescriptions at a time.

This means occasional prescribing of a 3-7 day script to bridge a patient to an outpatient provider makes having 30 active prescriptions at a time virtually impossible. Once the prescription runs out for bridging purposes, it falls off that list and goes back to ZERO.



### CHOOSE TO APPLY FOR ONLY THE 30-PATIENT LEVEL.

Under the notice of intent, you are only able to apply for the 30-patient level.

#### New Applicant Eligible For Waiver Level 30 or 100

Based on the credentials entered, you appear to be a new applicant. If this is not the case and you have previously submitted a waiver applic resubmit so that we can link your new activity to your existing account. #### Starting at the 100-Patient Level

New legislation makes it possible for practitioners to apply for a waiver at the 100-patient level if they meet the following condition(s):

No O Yes I provide medication-assisted treatment with covered medications (as such terms are defined under 42 C.F.R. § 8.2) in a qualified p C.F.R. § 8.615.

You are applying for the 30-patient level at this time. Press the Next button to begin your application.

### AFTER THE NOI IS REVIEWED, YOU WILL RECIEVE A X-DEA NUMBER.

This process has up to 4-6 weeks turnaround from SAMHSA. This X-DEA number is for the 30-patient level only and will be used on each BUP prescription.
